City of Hartington Economic Development Program**

Shall the City of Hartington establish an Economic Development Program as described here by appropriating annually from local sources of revenue thirty-five percent (35%) of a one and one half (1 1/2 %) local option sales and use tax estimated to generate \$112,500 per year for an estimated 15-year total of approximately \$1,687,500?"

**SPECIAL ELECTION ISSUE
City of Hartington Sales Tax issue**

Shall the City of Hartington, Nebraska, impose a sales and use tax in the total amount of one and one-half percent (11/2%) within the City of Hartington, Nebraska, upon the same transactions within the City of Hartington on which the State of Nebraska is authorized to impose a tax for the fiscal year of 2021-2022?"

**SPECIAL ELECTION ISSUE
Village of Fordyce Sales Tax Issue**

Shall the Governing Body of the Village of Fordyce, Nebraska, impose a sales and use tax of one percent (1%) upon the same transactions within the Village of Fordyce, Nebraska on which the State of Nebraska is authorized to impose a tax commencing April 1, 2021. The revenue to be applied to street maintenance and improvements, and the general operation of the Village, increasing its budgeted restricted funds for fiscal year 2020-2021 by \$6600.00, 11.093 % over the current year's restricted funds."


**SPECIAL ELECTION ISSUE
Laurel Concord Coleridge School District 0054 Bond Issue**

Shall Cedar County School District 0054 (Laurel Concord Coleridge Public Schools) in the State of Nebraska issue its general obligation bonds in an aggregate stated principal amount not to exceed Twenty-three Million Dollars (\$23,000,000), for the purpose of paying costs of additions, renovations and improvements to existing facilities of the District together with related site improvements; and providing for the necessary furniture, equipment and apparatus for such facilities; such bonds to be issued from time to time, to bear interest at such rate or rates, to be sold at such prices and to become due at such time or times as may be fixed by, or determined at the direction of, the Board of Education; and

"Shall the District cause to be levied and collected annually a special levy of taxes against all the taxable property in the District sufficient in rate and amount to pay the principal of and interest on such bonds as the same become due?"

The Secretary of State will publish a true copy of the title and text of any amendments or referendums once each week for three consecutive weeks preceding the election.
